BUILDING SAFETY, HOPE & HEALING

Since 1978, The Family Crisis Center has been a place of safety, compassion, and hope for children, women, and men affected by domestic violence, sexual assault, child abuse, human trafficking, and elder abuse. We know that healing begins when people feel seen, supported, and safe. Through emergency shelter, crisis intervention, victim advocacy, and community education, we walk alongside survivors as they rebuild their lives, regain their confidence, and look toward a brighter future. Every day, we remain committed to preventing violence, strengthening our community, and helping break the cycle of abuse for generations to come.

We envision a community where every child and adult has a safe place to call home, the support they need to heal, and the opportunity to build a life free from violence and fear.



Through education, advocacy, and compassionate care, we are helping create a future where abuse is no longer accepted, survivors are empowered to thrive, and families can move forward with hope and resilience.

Together with our neighbors, community partners, dedicated volunteers, and supporters, we are building a stronger, safer community where healing is possible, hope is restored, and every person is treated with dignity, compassion, and respect.



WHAT WE DO

PROTECT

When someone is facing abuse, safety comes first. We provide immediate, compassionate support to help individuals and families find security and begin healing.

- **Emergency Shelter & Crisis Response** – Safe, confidential shelter, a 24/7 crisis helpline, emergency advocacy, safety planning, and assistance with protective orders.
- **Child Advocacy (Emmy's House)** – A child-friendly environment where children impacted by abuse can access forensic interviews, medical exams, victim advocacy, family support, referrals to counseling and community resources, and coordinated intervention services designed to reduce trauma and promote healing.

SUPPORT

Healing looks different for everyone. Our services are designed to meet survivors where they are and provide the tools, resources, and encouragement they need to move forward.

- **Advocacy & Support Services** – Guidance through legal and social service systems, including protective orders, safety planning, case management, and court accompaniment.
- **Counseling & Trauma Recovery** – Trauma-informed counseling, crisis intervention, therapy, and support groups that promote healing and resilience.
- **Economic Empowerment & Housing Assistance** – Financial assistance, employment support, transportation, housing resources, and other services that help survivors rebuild their lives and achieve lasting independence.

EDUCATE

Creating safer communities starts with awareness. We work to prevent violence by educating individuals, strengthening partnerships, and empowering our community to take action.

- **Community Education & Prevention** – Training, workshops, outreach, and awareness initiatives that help individuals and organizations recognize, respond to, and prevent abuse.
- **Collaborative Partnerships** – Working alongside law enforcement, healthcare providers, schools, businesses, nonprofits, and community leaders to strengthen prevention efforts and expand support for survivors.



STORIES OF HOPE & HEALING

EMERGENCY SHELTER

A New Beginning

A parent and their children came to our emergency shelter after leaving an abusive relationship and seeking a safer future. With support from staff, they created a safety plan, secured employment, arranged childcare, and built a foundation for independence.

Through continued support and community resources, the family transitioned into permanent housing and began a new chapter filled with stability, safety, and hope.

ADVOCACY & SUPPORT

Safety Beyond the Courtroom

A survivor reached out to the Family Crisis Center seeking safety after experiencing domestic violence. With support from an advocate, they obtained a protective order, created a personalized safety plan, and connected with counseling resources for themselves and their children.

When additional safety concerns arose, advocacy continued to ensure the family had ongoing support. Months later, the survivor shared that their family was safe, their children were thriving, and they were beginning to heal.

EMMY'S HOUSE CHILDREN'S ADVOCACY CENTER

A Child Finds Their Voice

A child was referred to the Children's Advocacy Center after concerns of abuse arose. Our team worked with the family to ensure the child could receive support in a way that reduced additional stress and barriers.

Through a child-centered forensic interview, the child found the safety and trust needed to share their experience. Before leaving, the child shared that they knew they had someone they could trust if they ever needed help again.

COMPREHENSIVE SURVIVOR SUPPORT

Walking Beside Survivors

A survivor entered services facing safety concerns, housing instability, financial hardship, and the challenge of navigating the legal system while protecting themselves and their child.

With advocacy, safety planning, emergency shelter, assistance obtaining a 50B protective order, case management, and support from multiple Family Crisis Center programs, they overcame barriers, accessed critical resources, and took meaningful steps toward a safer, more stable future.

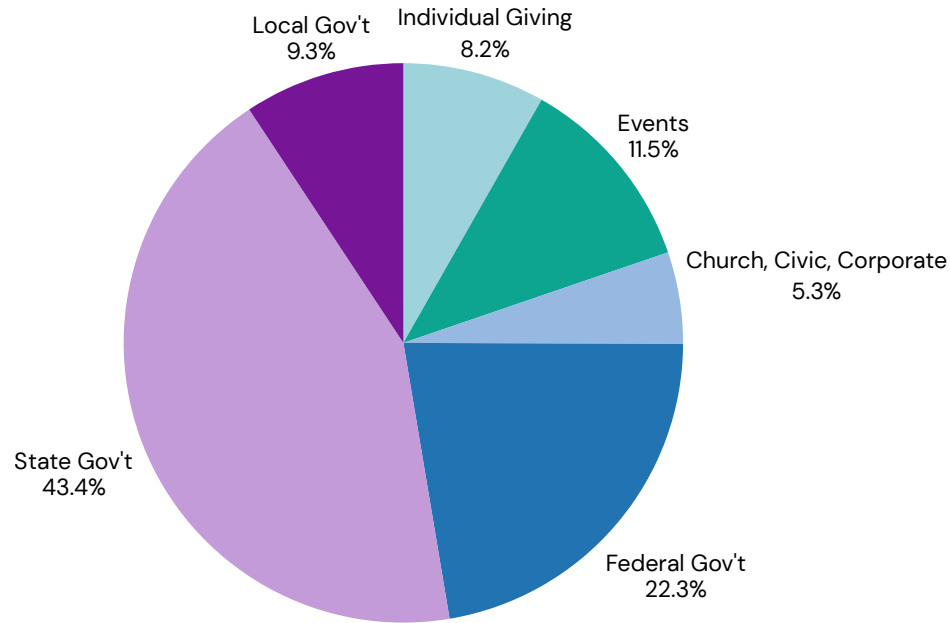
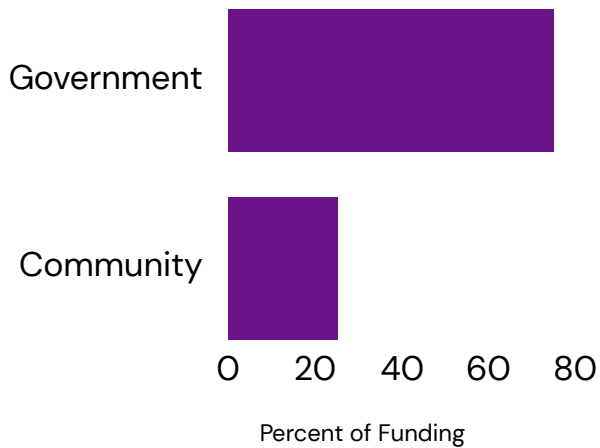

FUNDING SOURCES 25-25 FY



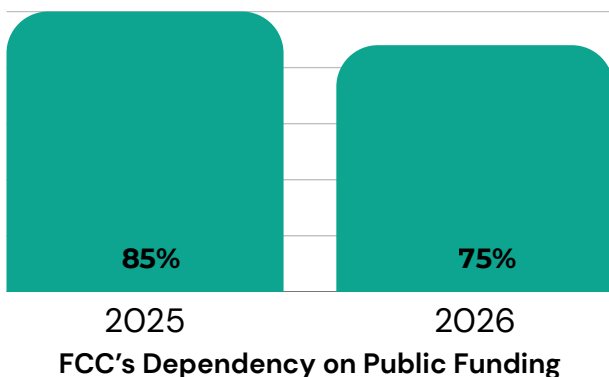
INVESTING IN A SUSTAINABLE FUTURE
